2. It is understood and agreed that studio cannot guarantee to produce any video product of any specific object(s), situation(s) person(s), or event(s) or in combination thereof, taken by studio in the performance of the duties and/or services specified in this assignment.
3. If the total job time exceeds four (4) hours, studio must either be supplied food and non-alcoholic beverage(s) by client or studio shall be permitted a time period not to exceed (1) hour to obtain refreshment.
4. Studio has the right to assign any videographer(s) for this assignment.
5. It is understood that studio is the exclusive official videographer, and others taking videos will be permitted only at our discretion.
6. In the event of a postponement or cancellation of this contract, the deposits paid may be used for any future event up to one year past the date of this contract providing studio has no other obligations for the future date. Cancellation would need to be 30 days in advance of event date. After that time, all deposits will be forfeited to studio.
7. Studio reserves the right to use the original tape and/or reproductions for display, publication or other purposes.
8. Studio takes utmost care with the respect to the exposure, editing, duplication and delivery of the video products and services offered. However, in the event the studio fails to comply with the terms of this contract due to any event or act outside of the control of the studio, the studio's liability is limited to the refund of the deposits.
9. Original unedited copies may be purchased @ \$20.00 for each tape. These tapes will be available for 2 months after delivery of edited master tape.
